How to give the money you raised to us

After your event, please collect your sponsorship money as soon as possible. Send a cheque or postal order to us. Cheques should be made payable to 'British Liver Trust'. Please don't send cash through the post as it's not safe!

VERY IMPORTANT – how to make sure we get even more money at no extra cost

By ticking the box headed 'Gift Aid' you are confirming that you are a UK Income or Capital Gains taxpayer. You have read this statement and want Children's Liver Disease Foundation and British Liver Trust to reclaim tax on the donation detailed below, given on the date shown. You understand that if you pay less Income Tax / or Capital Gains tax in the current tax year than the amount of Gift Aid claimed on all of your donations it is your responsibility to pay any difference. You understand that Children's Liver Disease Foundation and British Liver Trust will reclaim 25p of tax on every £1 that you have given.

The Gift Aid rules are different if the participant is deemed as gaining a benefit. HMRC defines this as an event in which the cost of taking part is covered by CLDF/BLT or some of the sponsorship money. If the participant is receiving a benefit such as this, donations given by people who are connected to the participant are not able to be given under Gift Aid.
